#### 9 **MEMBERSHIP**

The only change in membership to report was that the Wirral Transport Users Association had withdrawn its membership as it no longer had a representative who could attend, although it was noted that Cedric Green, who attended meetings on behalf of the North Cheshire Rail Users, could feed back any required information to the Association.

Nominations were invited to be the Committee's representative on the Airport Transport Forum.

Councillor Chris Ellams nominated Steve Pearse. Bob Swann seconded the nomination.

There were no other nominations.

#### 11 CUSTOMER SERVICES UPDATE (TABLED AT MEETING)

Christina Smith, Customer Services Manager, circulated her report to the Committee which covered December 2019 and January 2020.

Engagement and feedback had decreased in January but there had been many contacts following an aircraft incident on 11 December, when a

business aircraft slid off the runway and caused a day's flights to be cancelled. This had boosted December's engagement figures above the normal level.

Satisfaction was 86% of those who had responded (which were 37% of enquirers). It was noted that some areas of concern, such as check in times, were airline policy rather than due to the airport. Accessibility experience issues had been addressed through familiarity visits for people who were anxious about using the airport, autism ambassador training and dementia awareness training.

Members questioned aspects of the report and it was confirmed that:

- all media types were used to gather feedback
- passenger traffic figures would be included in future to provide context
- Complaints amounted to around 0.1% of passengers
- The airport reported carbon emissions annually and had almost halved since 2010 and were in the process of agreeing net carbon zero by 2040 plan, aligning with the Liverpool City Region. There were plans for a solar array and possibly ground source heat pumps.

Resolved – that the update be noted.

#### 12 **AIRSPACE CHANGE**

Andrew Dutton, Head of Environment at the Airport, updated the Committee on the progress toward airspace change around the Airport.

Although Liverpool Airport had one physical runway, it could be approached from two directions, and these two runways were always referred to as runway 27 and runway 09. Aircraft flew into the wind on landing and taking off, from 27 in the prevailing westerly wind whilst 09 is used when the wind was from the East. This significantly changed the areas being overflown. The Main reason for the Airspace Change Proposal (ACP) was to seek to change to satellite navigation from land-based beacon navigation. This narrowed the flight corridors and led to some properties being overflown more but more properties overflown less.

The Airport was following guidance published by the Civil Aviation Authority (CAA) in CAP1616 which was a 7-stage process. Liverpool were at stage 3 which was a formal consultation on the proposed options. That stage ended on 9 April and the Airport aimed to submit plans to the CAA in in July 2020, with either proposed implementation in Winter 2021/22 or co-ordination with the other Manchester Terminal Manoeuvring Area (MTMA) airspace users.

The consultation was a transparent process with comments ideally made on the CAAs portal

(https://airspacechange.caa.co.uk/PublicProposalArea?pID=28) where the

proposal was detailed and the wider process and stages shown. Comments from individuals and organisations were welcomed whether they were positive or negative and all were encouraged to participate via the CAA portal.

Resolved – that the update on airspace change be noted.

#### 13 **QUARTERLY REPORT**

Robin Tudor, Head of Public Relations at the Airport, presented his update report for October to December 2019 to the Committee.

Passenger numbers were down by 0.04% on the previous year but the annual total had been over 5 million passengers once again which placed Liverpool in the middle ground for airport size. It had been a challenging year for the Airport as it has for all in the UK aviation industry, with the demise of Thomas Cook and difficulties experienced by Flybe, high profile examples of the current environment. As a consequence, remaining flat in terms of growth was viewed positively knowing that other UK Airports were experiencing a decline in traffic. The Airport had been closed for a day in December 2019 following an incident when a business jet slewed off the runway at the start of the day. Most passengers were bussed to other airports for their flights, but some aircraft ended up at the wrong airports which later led to flight cancellations.

Looking ahead for 2020, it was expected to be another tough year for the industry, with continued challenges including lack of aircraft availability due to the grounding of the Boeing 737 Max due to safety concerns, which had affected airlines including Ryanair who had hoped to take delivery of the first of over 200 such aircraft in 2019.

Freight business at the Airport has seen good growth in 2019 and it is hoped that this will continue in 2020 too.

The extension of the Runway End Safety Area (RESA) to and associated works to the east of the runway have finally been completed.

Members questioned Robin on the report and it was confirmed that:

- links to a hub airport were still being pursued
- a meeting was due to take place to look at improving live airport/rail information at Liverpool South Parkway (LSP) and the Airport.
- Comment was made that the airport flight information screen at LSP had not been working. (following the meeting further feedback indicated that this problem had subsequently been resolved.)
- Visit Britain in partnership with Marketing Liverpool had helped to fund a rebranding of the arrivals walkway to showcase the Airport as a gateway to North West England and North Wales with imagery of areas such as Liverpool, North Wales, Chester, the Lake District and Manchester to promote access to the region vide ideas and encourage multiple visits via the Airport.

Resolved – that the quarterly report be noted.

#### 6 MINUTES OF LAST MEETING

#### Resolved -

#### 7 NOISE COMPLAINTS

Andrew Dutton detailed the situation since the 'lockdown' had started as a result of the Covid-19 pandemic.

The aviation industry was probably one of the first industries to be hit by the pandemic as people stopped travelling. From 23 March passenger numbers dropped significantly and subsequently about 50% of staff were furloughed. From April onwards airlines cut schedules, the Airport restricted opening hours but stayed open for 11 (mainly medical passengers) flights a week by Logan Air to the Isle of Man.

The terminal was closed until a handful of other flights restarted in June. Whilst the terminal was closed the Isle of Man passengers used the business

aviation centre. When the terminal first opened there were very few concessions open but they had started reopening in July.

Regarding noise complaints, it was noted that the records for the period January to March were not yet accessible as the staff involved had been furloughed, but it was expected that they would be accessible in time. For the period April to June there had been 6 complaints from 4 individuals, with only two complaints about specific aircraft and none involving commercial flights. There was a concern that once operations get back to more like normal, there may be a spike in complaints as people had got used to having very few aircraft movements.

#### Resolved – that

- (1) the difficulty of accessing the noise complaints between 1 January and 31 March be noted; and
- (2) the noise complaints from 1 April to 30 June be noted.

#### 8 AIRSPACE CHANGE

Andrew Dutton provided a reminder of the background to the Airspace Change Proposal (ACP), including that: The process started with a submission/request to the Civil Aviation Authority (CAA) in February 2018; LJLA is following the CAP 1616 guidance; full details and staging were available on the CAA Airspace Change Portal; on 13 January 2020 the airspace change consultation began as (stage 3) - consulting on 6 potential options for routes; as part of the consultation there had been open sessions on 12 February and 7 March; the consultation had been extended to 27 April, and had included newspaper notices and messages on BBC radio, Instagram, Facebook, LinkedIn and Twitter with regular updates.

The consultation report, to include feedback had been drafted and would be published on the Portal. There had been over 800 responses although some people still claimed they had not been made aware.

that the Airspace Change update be noted.

#### **QUARTERLY BUSINESS REPORT**

#### 1.0 Airport update

#### Commercial passenger traffic

At the last meeting of the Consultative Committee it would have been hard to imagine just how much the world and all our lives would change over the next six months. For aviation in particular, the coronavirus pandemic has undoubtedly created the biggest crisis in living memory and Liverpool like all other UK airports has experienced a huge decline in business as a consequence.

The table below highlights the impact on passenger numbers, with the effects of the pandemic first seen in late February/early March as the number of cases spread across Northern Italy.

With the introduction of the lockdown period, air travel almost ceased entirely. The Airport at no point closed however, with operations maintained for Loganair's twice daily Isle of Man flights, which were essential for passengers from the island who needed to access health care in the North West and to help with the supply of PPE to the island.

At this time, the Airport terminal building closed and passenger processing took place via the XLR Executive Aviation facility, in order to reduce costs, whilst the introduction of the furlough scheme saw around 60% of airport employees placed on furlough.

During the lockdown period, staff at the Airport put plans in place in order to be able to recover once the lockdown measures were lifted and airlines began to re-introduce flights. These included comprehensive cleaning regimes, self-distancing information and PPE related measures to protect passengers and airport staff.

Flights with Wizz Air, easyJet and Ryanair began to recommence in May and over subsequent weeks more destinations were re-introduced, with over 50 destinations being served in August. However the frequencies of flights has been significantly lower than would have normally been scheduled to operate and the load factors (level of occupancy) on flights has likewise been much less than would be seen during what should be the busiest time of the year for the Airport.

Unfortunately the initial introduction of 14 day quarantine restrictions for all passengers arriving from overseas and then subsequent restrictions being reintroduced on what would be some of the Airport's most popular routes (Spain, France, Portugal etc) has continued to cause confusion and undermine passenger confidence with many choosing not to travel overseas this Summer. This in turn continues to have a damaging impact on all UK airports including Liverpool.

Passenger numbers are currently down by around 65% and numbers of flights by around 40% and the Airport has subsequently been forced to make a number of redundancies as have other large employers based at the Airport, who are all faced with reduced passenger numbers and escalating costs. The forthcoming Winter season is expected to be equally as difficult for the industry.

Whilst the current situation remains extremely challenging for everyone, for those passengers travelling through the airport on flights, the overall customer experience remains good however with queues kept to a minimum where possible and most retailers have reopened in the Departure Lounge.

Passengers have been able to travel from Liverpool with plenty of space to self distance and to relax and wait for flights. The 'Eat out to help out' scheme proved particularly popular with a number of the food and beverage outlets participating in the scheme.

There have also been some new route announcements too with Wizz Air announcing new services to Vilnius the capital of Lithuania, Bacau in Romania and Chisinau the capital of Moldova, all starting in late October and Ryanair announcing a new service to Kosice in Slovakia, also starting at the end of October.

Aviation was one of the first industries to be impacted by the pandemic and is likely to be one of the last to recover, with further uncertainties likely over the coming weeks and months. The Airport Operators Association which acts on behalf of UK airports continues to lobby Government for more support and improvements to the existing unpredictable quarantine rules.
