43 NOISE COMPLAINTS LOG

The Sub-Committee considered the Noise Complaints Log, which detailed the complaints received and the responses, for the period 1 January 2019 to 31 March 2019. Colin Barnes gave a presentation to members on the Noise Log which included analysis of the number of noise complaints received by date, number of complainants, administrative area and the total number of complaints compared to the previous year. He also detailed the number of engine test runs. The presentation is attached to these minutes.

During the period a total of 5,507 complaints had been received, although 5,501 were from one individual and 6 were not.

Members discussed different types of airport noise which could cause disturbance, including noise from ice-clearing machines and different models of aircraft.

44 DEMONSTRATION OF TRACKING SYSTEM

Colin Barnes gave a further demonstration of the new tracking system which was used to monitor and record noise events. He showed the members the queries which the system highlighted each day where the system could not directly relate a noise to a particular aircraft. Operators could then play the audio of the event and simultaneously view aircraft movements in the vicinity to see if the two were related.

Airspace Change


Dave Batt, Head of Asset Management, updated members on the proposed changes to airspace at the Airport which had been caused by the transition from land based navigation beacons to satellite based guidance. The new process was called CAP 1616 and Liverpool were among the first Airports to follow the process, which involved 'gateway' points in the process, and the Airport had been congratulated on the quality of the submission. The Airport was now at Stage 2 which was developing and assessing proposals before a formal consultation, with a proposed implementation date of Spring 2021.

The Runway is one physical strip of tarmac which is 45 meters wide. The runway can either be operated in an east-to-west direction ('Runway 27'), or a west-to-east direction ('Runway 09'). The direction in which Air Traffic Control at the airport operate the runway is decided predominantly but not exclusively by the direction and strength of the wind at that time, it is far safer and efficient for aircraft to take off and land into the wind.
